## Speaker: Dr Simon Treadwell, Little River Flow Study



Simon returns to tell us about the final definitive findings of the recently completed Little River Flow study. Simon works with SKM consultants who conducted this major study for Melbourne Water. Simon held our members spellbound when he spoke to us earlier this year and had the audience fascinated with his detailed factual knowledge about the River. Now the report is completed Simon has some very interesting results to report and will be able to tell us about some specific changes in management that should lead to more regular flow in the upper reaches of the River and improved maintenance of the River during dry spells. He also has some very interesting findings to report about the impact on river flow of extraction of water for domestic supply, the effects of farms dams and ground water extractions. Anyone with any interest at all in the Little River and its surrounds must attend this talk!!!

#### New Committee Member: Tony Farrugia

#### Vision for Werribee Plains

LeadWest conducted a Community Forum on the 7/10/10 to discuss the implementation of the Werribee Plains Regional Environmental Sustainability Framework. This Framework was released in March as part of the Victorian government's Vision for Werribee Plains (V4WP) program, which aims to transform the region into a global leader in water management and sustainable development. Four of the projects funded by V4WP were presented to the forum by the project managers followed by a panel discussion addressing the three themes of the framework, Water, Energy and Natural Environment

#### Locust Outlook

Moorabool Shire Council recently hosted an information session led by Erica Schelfhorst, DPI Bendigo on the present situation with the expected locust outbreak this year. All crops and pastures in much of the north and west of Victoria are under threat.

Locusts laid extensive egg beds in many areas north of the Divide earlier this year. The Australian Plague Locust Commission anticipate the eggs will start hatching in late September in the most northerly parts of the State and a month or so later further south.

Two to three weeks after hatching, when the hoppers begin to form bands, is the best time to begin control spraying. Much of this control will be in the north and not affect our area. However if significant numbers of mature locusts are blown south local landowners may need to be prepared to control second generation locusts (the life cycle takes only 5-6 weeks).
